* Remarks about information provided by the platform:

1. Purpose for providing victims with criminal case details:

The judicial authorities are expected to protect victims' litigation information and uphold the concept of justice for the people, with a view to implementing warm and empathetic justice.

2. Persons entitled to petition:

(1) Victims of robbery, kidnapping, assault and sexual assault, or other persons related to the victim's interest and deemed necessary to receive information by the prosecutor.

(2) If the victim of the above specific cases is a person with no legal capacity or limited legal capacity or if the victim is deceased, the petition may be made by the victim's spouse, lineal family member, non-lineal family member within 3 degrees of kinship, marital family member with 2 degrees of kinship, the head of family or household member (not limited to one person).

3. Manner of petition:

A Victim's Petition for Disclosure of Criminal Case Details should be completed and filed with prosecution authority that is investigating or enforcing the case if the case is under investigation or enforcement, or filed with the court that is reviewing the case if the case is on trial.

4. Information disclosure manner:

After the petition is approved by the relevant authority, the victim's criminal case details will start to be established and uploaded to the Criminal Case Details Disclosure Platform for Victims. When there is case information that is subject to disclosure, an email will be sent to the petitioner. The petitioner may also log into the platform to verify case details.

5. Scope of information disclosure:

Matters of the victim's concern during litigation process:

(1) During investigation: The result of prosecutor's compulsory measures against the defendant (such as release on bail, release to custody of another, restricted residence, petition for detention, cease of detention, etc.), investigation result and the defendant is under a warrant of arrest.

(2) During trial: Court judgment, compulsory measure during trial, etc.

(3) During enforcement: Inmate imprisonment, application for parole and release from prison, etc.

6. Cease of procedure:

The petitioner may make a written submission at any time to stop disclosure of case details.

7. The prosecution authority will only provide case details occurring or continuing after the petition is approved.
